## Freedom of Information Act 2000 (FOIA)

Thank you for your request, which was received on 24 March, for the following information:

"HMRC has developed Check Employment Status for Tax (CEST). In your response to FOI request FOI2018/00162 you stated that ?The CEST tool testing was done by workshop where officials, lawyers, tax and IT professionals developed the set of rules that under-pin the tool.? We asked for the results of 7 particular IR35 cases and you indicated that you held records when your response stated ?Our records show that HMRC has used the CEST tool to test all the cases cited in your request? Regarding these records related to the testing of CEST, including the records for which you ascertained the results of those 7 cases, please can you provide: 1. A list of all of the cases use for testing where decisions were made in court (and therefore on public record) 2. For the settled cases, which were not court cases: The number of cases used for testing. Please can you also provide: ? A list of all documents/records mentioned in FOI2018/00162 related to the testing procedures. ? Provide copies of such documents."

Following a review of the paper and electronic records we hold, I have established that HMRC does not hold the information you requested.

The CEST rules were developed in a workshop, from which the only documented output is the agreed set of rules used by the CEST, and which are already in the public domain. We did not create and do not therefore have lists of court cases, or settled cases or documents used in the testing procedure from when the CEST was in development. However we do have a very similar list of cases and test results we produced after CEST's development. This list includes the seven cases you asked us about.

Although I am unable to answer your FOIA request, I can provide some information outside of the Act on a discretionary basis.

1. A list of all of the cases use for testing where decisions were made in court (and therefore on public record)

We do not hold a complete record of all the cases CEST was tested against during development but have a further similar table including other status cases and results which you might find helpful:

We did not keep a count of the numbers of cases. The officers involved estimate that they tested CEST against around 400 settled cases.
